

# Information about CEAWA Membership

## MEMBERSHIP

Membership is by application and payment of an annual fee. The membership year is 1 January to 31 December.

Members are from a range of backgrounds and may possess a variety of skills in key areas or may have an interest in career-related services and research.

Membership is available to individuals in the following categories.

- **Professional** (*Metropolitan \$88; Rural and Remote \$55*)  
Individuals who have completed a CICA endorsed career development specific Graduate Certificate or higher qualification
- **Associate** (*Metropolitan \$77; Rural and Remote \$44*)  
Individuals who have not completed a CICA endorsed qualification but are working in the career development area
- **Affiliate** (*Metropolitan \$77; Rural and Remote \$44*)  
Individuals who do not qualify to become Professional or Associate members

All categories have a once only joining fee of \$11 including GST.

## CONTINUING PROFESSIONAL DEVELOPMENT

CEAWA has introduced a continuing Professional Development program that conforms to the requirements of the Professional Standards for Australian Career Development Practitioners. These standards have been adopted by the Career Industry Council of Australia Inc. (CICA) and its member associations, one of which is CEAWA.

Continuing Professional Development is:

- Mapped against the Professional Standards for Australian Career Development Practitioners (the Standards);
- Accessible to all members;
- Flexible and meets the range of practitioner needs;
- Designed to enhance practitioners' ability to understand, acquire, develop and maintain the competencies of the Standards
- Caters for both new and experienced members
- Includes both formal and informal opportunities and work-based learning.
